NEW LANDSCAPING AND SNOW REMOVAL CONTRACTS

The Board and Architectural Committee found out during our first January snow event that our contractors, Edward's Landscaping, dropped our contracts.

Brenda and the Board worked together to hire a new contractor (DEL Landscaping) who will be starting our landscaping upkeep in March. Our snow contract with DEL Landscaping will take us through this year.

HOW FAST WAS THAT CAR?!?

For a few days last December, we had two RADAR Speed Boards in our neighborhood that displayed speeds over 25-mph. The Traffic Enforcement Section (TES) of Howard County Police posted the boards to decide if our area needed additional enforcement. Here are some highlights.

For westbound (WB) vehicles from Rt. 1 onto Bonnie View Lane:

· Ave. number of vehicles/day: 279.2

 Ave. speed: 22.3-mph · Highest speed: 45-mph

For eastbound (EB) vehicles from Lawyer's Hill Rd. onto Summer Home Terrace:

· Ave. number of vehicles/day: 1,275.5

· Average speed: 12.7-mph · Highest speed: 91-mph

Surprisingly, the maximum speed recorded was 91-mph. Even if this was an error, there were still speeds of 69 and 52-mph. Please keep yourself safe and watch out for dangerous drivers. Also interesting was the difference in speeds and volumes between the WB and EB sians.

Because the prevailing speeds (checked at the 85th percentile) were below or close to the speed limit, we won't receive additional enforcement. Instead, TES will have the boards return to our community to remind drivers of the speed limit and encourage better driving. The full reports are included at the end of The Docket.






